- A.** All Emergencies – Dial **911**
1. All *life threatening* situations
  2. All suspected crimes in progress (examples include, but not limited to)
    - a. Prowling
    - b. Battery
    - c. Robbery
    - d. Shots Fired/Shootings
    - e. Burglary
- B.** Non Emergencies – Dial **933-4444**
1. When an officer is needed at the scene but the situation is not life threatening.
    - a. Loud Music
    - b. Neighbor trouble (non-violent)
  2. To speak to a Communications Supervisor – **Dial 935-7472**
- C.** District Notifications – Dial **935-7252** (5<sup>th</sup> District)
1. Non-emergencies when a squad is not needed. (Examples are, but not limited to)
    - a. Vacant house (on vacation and would like squad to check home)
    - b. FAX number **935-7115** (Hot spot forms or drug complaint forms)
