THE FINANCIAL CLINIC COMBINES BOTH ONE-ON-ONE FINANCIAL COACHING AND GROUP-BASED EDUCATION TO HELP PARTICIPANTS IMPROVE FINANCIAL BEHAVIORS. IN 2020, THE FINANCIAL CLINIC SERVED 232 CLIENTS. THROUGH THESE SERVICES, 64 CLIENTS INCREASED THEIR CREDIT SCORES AND 19 BECAME PREAPPROVED FOR PURCHASING HOMES.
